The mission of the Office of Inspector General (OIG), as mandated by Public Law 95-452, as amended, is to protect the integrity of the Department of Health and Human Services (HHS) programs, as well as the health and welfare of beneficiaries served by those programs. This statutory mission is carried out through a nationwide network of audits, investigations, and inspections conducted by the following operating components:

## *Office of Audit Services*

The OIG's Office of Audit Services (OAS) provides all auditing services for HHS, either by conducting audits with its own audit resources or by overseeing audit work done by others. Audits examine the performance of HHS programs and/or its grantees and contractors in carrying out their respective responsibilities and are intended to provide independent assessments of HHS programs and operations in order to reduce waste, abuse, and mismanagement and to promote economy and efficiency throughout the Department.

## *Office of Evaluation and Inspections*

The OIG's Office of Evaluation and Inspections (OEI) conducts short-term management and program evaluations (called inspections) that focus on issues of concern to the Department, the Congress, and the public. The findings and recommendations contained in the inspections reports generate rapid, accurate, and up-to-date information on the efficiency, vulnerability, and effectiveness of departmental programs.

## *Office of Investigations*

The OIG's Office of Investigations (OI) conducts criminal, civil, and administrative investigations of allegations of wrongdoing in HHS programs or to HHS beneficiaries and of unjust enrichment by providers. The investigative efforts of OI lead to criminal convictions, administrative sanctions, or civil monetary penalties. The OI also oversees State Medicaid fraud control units, which investigate and prosecute fraud and patient abuse in the Medicaid program.

## *Office of Counsel to the Inspector General*

The Office of Counsel to the Inspector General (OCIG) provides general legal services to OIG, rendering advice and opinions on HHS programs and operations and providing all legal support in OIG's internal operations. The OCIG imposes program exclusions and civil monetary penalties on health care providers and litigates those actions within the Department. The OCIG also represents OIG in the global settlement of cases arising under the Civil False Claims Act, develops and monitors corporate integrity agreements, develops model compliance plans, renders advisory opinions on OIG sanctions to the health care community, and issues fraud alerts and other industry guidance.

This letter report provides you with the results of our programmatic review of discretionary grant number #90EF0041, awarded to the W.S.O.S. Community Action Commission, Inc. (W.S.O.S.). This two-year grant is part of an on-going effort to improve the water quality and sanitary wastewater treatment for low-income rural areas. The purpose of our review was to determine whether W.S.O.S. met the objectives specified in the grant award. We found that W.S.O.S. did meet the grant objectives and, therefore, we make no recommendations for improvement or change.

### INTRODUCTION

#### BACKGROUND

This grant, dated September 21, 1998, was to be used to assist in improving drinking water quality and sanitary wastewater treatment for residents of low-income rural communities within the seven state Great Lakes area. The grant was for a two-year period, September 30, 1998 to September 29, 2000 at a cost of \$1,052,456.

The grant had several specific performance goals, including: (i) number of community needs assessments done, (ii) total population served, (iii) low income population served, and (iv) the number of new water systems established. This grant is similar to numerous others that W.S.O.S. has received for the same purposes going back to the early 1980s.

The majority of the grant (76%) was for sub-contracts to field agents to perform community needs assessments in the seven state area. The remainder of the grant (24%) was for administrative costs of W.S.O.S.

#### OBJECTIVES, SCOPE, AND METHODOLOGY

Our audit was conducted in accordance with generally accepted government auditing standards. The purpose of our audit was limited to an assessment of grantee performance in achieving project objectives and complying with the terms and conditions of the grant award. To accomplish our objective, we: (i) interviewed the project director, (ii)

reviewed semi-annual and annual progress reports, and (iii) reviewed selected sub-contractor community needs assessments.

Our fieldwork was performed at the W.S.O.S. Community Action Commission, Inc. office in Fremont, Ohio in June 2001.

### RESULTS OF REVIEW

We found that the grantee had accomplished the objectives and goals of the grant. In order to achieve the grant objectives, the W.S.O.S. relies largely on subcontracts with technical experts to perform community needs assessments, and to work with local officials to resolve drinking water and solid waste problems. The subcontractors submit their reports, and W.S.O.S. compiles and summarizes the overall statistics into annual reports to the granting office.

We reviewed the statistics in the W.S.O.S. annual reports to determine if grant objectives were being met. In addition, we selectively tested the statistics contained in the annual reports back to supporting subcontractor reports to insure that the statistics were accurate.

Following are significant statistics that W.S.O.S. reported:


