Many Tribal programs receive funds from the Department of Health and Human Services (HHS). Have you ever wondered if you are meeting all the requirements to protect that revenue stream and the beneficiaries it is intended to serve? - understand the importance of internal controls and single audits;
- identify key elements for ensuring quality of care;

- serving beneficiaries,
- protecting program funds,
- ensuring compliance with applicable regulations and laws,
- submitting claims to the Federal Government,
- internal auditing and/or maintaining documentation, and/or
- overseeing the quality of services provided to beneficiaries.

From Interstate 235/Broadway/UC77: Follow U.S. 77/Broadway into Edmond northbound to East 2nd Street. Turn onto East 2nd Street eastbound for approximately 0.5 miles to Garland Godfrey Drive and turn left at stoplight.

Facing north, the building directly in front of you is the Nigh University Center. Entering through the main front doors, you are on the 2nd floor of the building.
